OFFICE MEMORANDUM

Sub:- Standard Operating Procedure for grant of Prospecting License and/or Mining Lease for Coal in the State of Meghalaya.

No.MG.60/2014/Pt/398. - The Government of Meghalaya hereby notifies 'Standard Operating Procedure' [hereinafter, '**SOP**'] for processing the Applications submitted under the Mineral Concession Rules, 1960 (as Amended from time to time) for obtaining previous approval of the Central Government for grant of Prospecting License and/or Mining Lease for Coal in the State of Meghalaya:

The SOP shall govern the following:

CHAPTER-I APPLICATION FOR GRANT OF PROSPECTING LICENSE

2. That landowner shall submit an application to Central Government in quadruplicate, in **Form-A** of this SoP through the State Government, for obtaining the previous approval of Central Government for grant of Prospecting License/Mining Lease.

A. APPLICATION FORMAT & DETAILS [PROSPECTING LICENSE]

3. The application shall be made in **Form A** enclosed to this SoP.

B. COVER LETTER

- 4. The cover letter shall contain the following:
 - A declaration to the effect that the application is being made on behalf of a Tribal who owns land in the Sixth Schedule Areas of the State of Meghalaya;
 - b. A declaration to the effect specifying status of the Applicant as to whether the applicant is exempt from payment of income tax as per Section 10(26) of the Income Tax Act, 1966;
 - c. A declaration to the effect that the application is being made under the provisions of Chapter IIIA and/or Chapter V of the Mineral Concession Rules, 1960 (As amended up to date);

- d. A declaration to the effect that the application in 'Form A' along with the respective enclosures have been duly authenticated by the respective Departments of the Government of Meghalaya or a Nodal Officer which may be appointed by the State Government for that purpose;
- e. A declaration to the effect that that the English translated version of documents submitted in support of the application (if any) are true and correct translations of the respective originals.

E. <u>MISCELLANEOUS.</u>

- 6. An application for prospecting license shall be for an area not less than 100 Hectares.
- 7. The application, along with all enclosures shall be forwarded by the Mining and Geology Department, Government of Meghalaya to the Ministry of Coal Government of India, New Delhi for obtaining previous approval of the Central Government for granting prospecting license.
- 8. The Mining and Geology Department, Government of Meghalaya shall reserve the right to reject any application made for grant of prospecting license in the event the same is found to be incomplete or unsuitable for recommendation to the Central Government.
- 9. After grant of previous approval from the Ministry of Coal, the State Government shall convey approval to the land owner for granting prospecting license in favour of applicant/lessee.
- 10. The State Government, through the Directorate of Mineral Resources, may carry out prospecting operations as per the Second proviso to Section 4 of the Mines and Minerals (Development and Regulation) Act, 1957 on application being made by land owners or project proponents, on such terms and conditions as may be prescribed by the State Government.
- 11. The prospecting data of any prospecting operations carried out by the Directorate of Mineral Resources, Government of Meghalaya may be provided to such applicants who are interested in making applications for prior-approval of mining lease, on the basis of such prospecting data subject to payment of fee as may be prescribed from time to time.

CHAPTER-II APPLICATION FOR GRANT OF MINING LEASE

A. APPLICATION FORMAT & DETAILS [MINING]

12. The application shall be made in 'Form B' enclosed with this SOP.

B. <u>COVER LETTER</u>

- 13. The cover letter shall contain the following:
 - a. A declaration to the effect that the application is being made on behalf of a Tribal who owns land in the Sixth Schedule Areas of the State of Meghalaya;
 - b. A declaration to the effect specifying status of the Applicant as to whether the applicant is exempt from payment of income tax as per Section 10(26) of the Income Tax Act, 1966;
 - c. A declaration to the effect that the application is being made under the provisions of Chapter V of the Mineral Concession Rules, 1960 (As amended up to date);
 - d. A declaration to the effect that the application in 'Form B' along with the respective enclosures have been duly authenticated by the respective Departments of the Government of Meghalaya or a Nodal Officer which may be appointed by the State Government for that purpose;

E. <u>MISCELLANEOUS</u>

- 15. An application for Mining Lease shall be for an area not less than 100 Hectares.
- 16. The application, along with all enclosures shall be forwarded by the Mining and Geology Department, Government of Meghalaya to the Ministry of Coal Government of India, New Delhi for obtaining previous approval of the Central Government for granting mining lease.
- 17. The Mining and Geology Department, Government of Meghalaya shall reserve the right to reject any application made for grant of Mining Lease in the event the same is found to be incomplete or unsuitable for recommendation to the Central Government.
- 18. After grant of previous approval from the Ministry of Coal, the State Government shall convey approval to the landowner for granting Mining Lease in favour of applicant/lessee.

19. Upon receipt of approval for mining lease by the State Government, a Mining lease shall be executed between grantor (land owner) and lessee and shall be registered in accordance with law. Certified copy of lease deed in duplicate shall be submitted to the State Government within 3 months of approval from the State Government as required under Rule 47 of MCR 1960. A Mining lease shall contain such conditions as may be agreed upon between the parties not being inconsistent with the provisions of the Act or rules.

CHAPTER-III: MINING PLAN APPROVAL

- 20. The Applicant who has received approval for mining lease and has executed the same shall submit a mining plan to the State Government, within a period of 06 months from date of preparation of geological report, for obtaining approval of the Central Government as per Chapter-IIIA of the Mineral Concession Rules. 1960 as amended from time to time.
- 21. The preparation of the Mining Plan shall be in accordance with the Guidelines for Preparation, Formulation, Submission, Processing, Scrutiny, Approval and Revision of Mining Plan No. 34011/28/2019-CPAM dated 29th May 2020 as notified by the Government of India, Ministry of Coal and as per the System of the State Government as approved by the Central Government under Section 22AA of the Mineral Concession Rules, 1960.

CHAPTER-IV: MINE OPENING AND OPERATIONS

- 22. Mine opening permission and notice of mining operation:
 - a) The lessee shall obtain permission for opening of coal mine and opening of Escrow Account for implementation of mine closure plan from Coal controller's Organization, Kolkata under Rule 9 of the Colliery Control Rules, 2004.
 - b) The lessee shall obtain approval to equipment, appliances, machinery apparatus and other materials used in mines from the Director General Mines Safety, Dhanbad under relevant provisions of Coal Mines Regulation 2017, the Metalliferous Mines Regulation, 1961, Mines Rescue Rules, 1985 framed under the Mines Act, 1952.
 - c) The lessee shall give notice of mining operations before commencement to the Chief Inspector, the controller of Indian Bureau of Mines and the District Magistrate under Section 16 of the Mines Act 1952. The Lessee shall furnish statements to the State Government and Coal Controller, Kolkata.
- 23. The Mining operations shall be undertaken in accordance with approved mining plan in accordance with Section 22A of the Mineral Concession Rules 1960 as amended from time to time, and in compliance of condition stipulated under the Environmental Clearance, Forest Clearance, consent to operate and other statutory clearances.
- 24. Transportation of Minerals has to be in accordance with Meghalaya Minerals (Prevention of Illegal Mining Transportation and Storage) Rules and as per the provisions and conditions of the approved mining plan.
- 25. Safety aspects: Safety of mine workers shall be ensured in compliance of Mines Act, 1952 and Coal Mine Regulations, 2017 with the approval of the Director General of Mine Safety.

- (xxv) Affidavit that up-to-date Income Tax Returns as prescribed under the Income Tax Act, 1961 and that the tax due including the tax on account of self-assessment has been paid in respect of both applicant and licensee, if applicable.
- (xxvi) Undertaking for compliance with requirements of Chapter-V of Mineral Concession Rules, 1960.
